

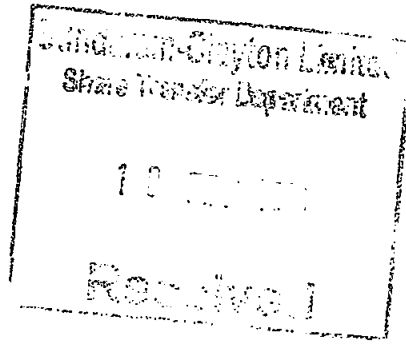


- 1) The New Address and Bank Details as per your records presently are correct and free of any discrepancies.
